Additional Information

Minimum call is one hour. 3 announcements can be claimed in a one hour session; one add'l announcement can be claimed for each subsequent 20 minute period.

All sessions with only one musician require that the single performer be paid at LAOC rate.

Pension for overscale performers is calculated at the scale rate.

Pension Contribution %:

thru 5/31/10 = 12%

6/1/10 thru 3/31/11=12.48%

4/1/11 thru 10/16/12=13.08%

First Double is 30%, each add'l Double is 15%. Leader and/or Contractor Doubles are calculated at the sideman rate.

Sessions employing 10 or more Musicians and Leader require a Contractor. The Contractor may be one of the Side Musicians.

Performers acting as both Arranger and Orchestrator receive reuse as Arranger only.

If a sideline musician falls into the category of principal performer under SAG/AFTRA, they are paid the SAG/AFTRA rates for session and use.

Premium rates apply on Sunday, Holidays and between midnight and 8:00am on weekdays.

Health & Welfare is \$17.00 + 3% of session wages (maximum of 2 lines for each performer, per report).

H&W on all Re-use, Conversion and Dubbing is 3% of scale wages only.

Cartage is \$12.00 for small instruments, drums and amps, \$30 for harp, keys, string bass, chimes, vibes.

“Made-for” Internet/New Media

Regular session fee if original session. First Use is \$34 SSM/\$68 LOAC for 1st 6 months if original session was intended for Internet Use. One Dub Fee (\$180/\$90) for second Six-Month cycle. One Dub Fee for each additional 52-Week cycle. If converted from other medium, one Dub Fee for each 52-Week cycle. Optional 8-week rate of \$34.20 SSM/\$68.40 LOAC.
